

Walk-in Interview for sports Coaches (past Champion Athletes)

The BBD UP Badminton Academy is a notified Khelo India Centre and is conducting a walk-in interview for 01 Coaches in the sports disciplines of Badminton. The contractual appointment will be purely on contract basis.

A. Eligibility criteria for past champion Athletes:

Order of preference	Individual Sports	Team Sports
1 st preference	recognized international competition under recognized	Represented India at recognized international competition under recognized NSF/Association of respective sport.
2 nd preference	National Past Championship	championship conducted by recognized NSF
3 rd preference	Medal winner at National AIU Past championship	Part of Medla winning team at National AIU past championship
4 th preference	National Past Championships conducted by recognized NSF OR	Represented State in Senior National Past Championships conducted by recognized NSF OR Participation in Khelo India Games

- B. Age Limit: Maximum age limit for applicants will be 40 year. However, relaxation may be accorded in deserving cases.
- C. Tenure: The contractual engagement will be initially for a period of 02 (two) years which could be further extended on the basis of performance.
- D. Remuneration: Fixed monthly remuneration of 25000/-, i.e. Rs. 3 lakhs per annum

- E. Eligibility Documents: The eligible and interested candidates may report with their original educational, professional, sports achievement certificates, ID proof and Aadhar Card at BBD UP Badminton Academy, Vipin Khand, Gomti Nagar, Lucknow.
- F. Tax Deduction at Sources: The income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment. For which the BBD Badminton Academy will issue TDS/Service tax certificates, as applicable
- **G. Other Allowance :** No TA/DA shall be admissible for interview and joining the assignment or on tis completion. No other facilities like DA, accommodation, residential phone, conveyance/transport, personal staff, medical reimbursement. HRA and I.TC. etc would be admissible.
- **H. Extension:** performance of the selected candidates would be continuously reviewed and their extension will be considered on the basis of periodic review/requirement.
- I. Leave: They will be entitled for 30 days leave in calendar year on pro-rata basis. Un-availed leave in a calendar year will lapse and will not be carry-forwarded to the next calendar year.

J. Other Condition:

- In case of performance is not found satisfactory BBD UP Badminton Academy reserves the right to terminate the contract by giving 30 (thirty) days notice to the past Champion Athlete. And BBD UP Badminton Academy also may withdraw offer at any time without assigning any reason.
