Entry Fees	Entry-Fees must be deposited before starting of the Tournament Match to organizing district association/Club. The entry fees for the tournament shall be as follows:				
	Singles Event of all categories – Rs. 1000/- per player				
	Doubles events of all categories -	Rs. 2000/- per pair			
Withdrawals	Any player failing to participate in any UPBA approved tournaments after draw is made, he/she is liable to pay the entry fees as a fine to UPBA before participating in next tournament. District Association / Club shall ensure for the deposition of the withdrawal fee to UPBA. No exemption under any grounds (including medical) will be allowed in payment of fine. No player is permitted to participate in the next tournament without paying fine. Referee shall submit the withdrawal list to UPBA within 48 hours after completion of the tournament.				
Mode of Completion	All matches shall be played on best of three games in rally point system. However if needed the Referee in consultation with Organizing Secretary may take the decision as per need of the situation.				
Regulations	The General Competition Regulations shall be applicable. In the even of any dispute, the decision of the Tournament referee will be final.				
Clothing Regulations	Players must comply with General Competition Regulations 20 to 24.
