| DOUBLE ENTRY | District forwarding names for Doubles partnering player from different District should have NOC or otherwise name of same pair should come from both the district failing which the entry will not be considered. |
| WITHDRAWALS DATES | <p>03rd June 2025.</p> <p>If there are any withdrawals after the close of entry. It shall be intimated to UPBA immediately by the Affiliated Units before the closing date of withdrawal.</p> <p>Any player failing to participate in any UPBA official tournaments after draw is made, he/she is liable to pay the entry fees as a fine to UPBA before participating in next official tournament. District Association/Club shall ensure for the deposition of the withdrawal fee to UPBA. No player is permitted to participate in the next tournament without paying fine.</p> <p>No exemption under any grounds (including medical) will be allowed to pay the fine.</p> <p>Referee shall submit the withdrawal list to UPBA within 48 hours after completion of the tournament.</p> |
| DRAW | Draw will be made on 04th June 2025 |
| MODE OF COMPLETION | All matches shall be played on best of three games in rally point system. However, if needed the Referee in consultation with Organizing Secretary may take the decision as per need of the situation. |

The Organizing Secretary/DBA, shall ensure to place the photographs of the Hon'ble Chairman & the President UPBA, at prominent places at the venue & outside. |

| PROTEST | <ol style="list-style-type: none"> 1- Any protest during the tournament can be given prior to the match or within 30 Minutes of completion of the match. The protest along with the relevant documents and protest fee will be submitted to Referee. 2- The referee will check the documents of the said player, if satisfy, the player against whom the protest has been carried out, will be declared successful / unsuccessful by the referee in the following manner. <ol style="list-style-type: none"> a) If the protest is successful the entire protest fee will be refunded to the protestant and the guilty player may be debarred from the tournament. b) In case of unsuccessful protest, disciplinary action may be initiated against the protestant player also. 3- If referee will not be able to verify the documents than he will submit the protest case to Organizing Secretary, so that he can forward the case to age screening committee of UPBA. 4- It is desired to all participants player to carry their birth certificate/age estimation certificate or any other relevant documents (original) for proof to verify his/her DOB to avoid the spot disqualification. 5- The fees for lodging protest of any kind shall be Rs. 5000. |
