No restriction on qualifying draws.

A Player can't participate in more than 3 (Three) events in tournament.

**Age of eligibility** :: Born on or after 1<sup>st</sup> January 2012 – Under 15 Years.  
Born on or after 1<sup>st</sup> January 2010– Under 17 Years

**Entries Closing Date** :: **12th May 2026**  
The Entries shall be received by BAI as per the existing system with a copy to Org. Secretary. The entries are to be received through **Affiliated Units only** at **entry@badmintonindia.org** (Direct entries from the Players will not be accepted)

**Doubles Entries** :: States forwarding names for Doubles partnering player from different States should have NOC or otherwise names of same pair should come from both the States failing which the entry will not be considered.

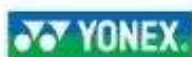
**Entry Fees** :: The entry fees will be as under :  
Singles events of all categories -- Rs. 1000/- per player  
Doubles events of all categories-- Rs. 2000/- per pair

Players of all Affiliated Units will be required to make the payment of entry fees for All India Ranking Tournaments to the Organisers. However, for the Walkovers of the players of various Affiliated Units, Hony. Secretaries of all Affiliated Units will be responsible to send the full amount of the walkovers concerned within Seven (7) days on receipt of the Walkover list through DD / NEFT to the Organizers concerned. The Referee of the Tournaments concerned will send the Walkover list State-wise to Chairman and Convenor, Tournament Committee, which will be forwarded to all the Hony. Secretaries of the Affiliated Units. The amount sent to the Organizers by the Affiliated Units on account of walkovers are to be reimbursed by the players who have given walkovers to the respective Affiliated Units. Affiliated Units will be at liberty not to send the entry of the players who will not reimburse the amount to the Affiliated Units for their walkovers.

**Mode of Competition** :: All matches in Main & Qualifying draw shall be played on best of three games of 21 points in rally point system. However, in case of huge entries, the Referee in consultation with Organising Committee, Chairman, Tournament Committee and Convenor, Tournament Committee may conduct qualifying matches in best of 3 games of 15 Points each with extension upto 21 points

**Regulations** :: The BAI Competition Regulations and General Competition Regulations shall be applicable.  
In the event of any dispute, the decision of the Tournament Referee will be final.

**Clothing** :: Players must comply with General Competition Regulations.

- Regulation** Any player committing a clothing violation from the 1st round of the main draw onwards will be fined Rs: 1000/-.  
Yellow Card – ₹500/- , Red Card – ₹2,000/-  
Balck Card – For Misconduct, disqualification and for possible follow up disciplinary action
- M&Q** :: First M&Q List will be published **on 18<sup>th</sup> May 2026**.  
The list of participants in order of strength will be displayed on BAI website. It shall be the responsibility of the affiliated units and the players to ensure that all the entries forwarded by the Affiliated Units appear in the M & Q (Main & Qualifying) List. If there is any omission, the player/s concerned immediately should contact their State Units and the State Units immediately inform BAI about the omission or proper rectification. After the Last date for withdrawals without penalty, no complaints shall be entertained for omission of any entry. BAI will not be responsible for any omissions of names thereafter.
- Withdrawals** :: **20<sup>th</sup> May 2026**.  
If there are any withdrawals after the close of entries, it shall be intimated to BAI immediately by the Affiliated Units before the closing date of withdrawal.
- Draw** :: Draw will be made one day before the qualifying draw and one day before the main draw at the venue in presence of Organizers/Players and BAI Officials, time of which will be notified by Referee.

**PROTEST** :: The fees for lodging protest of any kind shall be Rs. 5000.00 to BAI in prescribed form. Any protest shall be addressed to the Org. Secretary in writing within one hour after completion of the match or 4 hours before commencement of the match. Organizing Secy will forward the complaint and fees to BAI.

**TOURNAMENT OBSERVER** :: The President, BAI may nominate one Observer to this ranking tournament. The Chairman Tournament Committee /Convenor TC-BAI will attend the Tournaments / Championships to ensure smooth conduct of the Tournament.

**EQUIPMENT SPONSOR:** :: As per contractual agreement with Yonex/Sunrise, some agreed number of Shuttlecocks and T Shirts will be provided for the tournament. Additional shuttlecocks, if required, shall be purchased by the Organizer.

**FACILITIES** :: Organizers are requested to arrange for lunch for Main Draw Players. However, Main Draw Players have to mandatorily collect the Coupons for lunch one day in advance to avoid any wastage. Organizers will arrange lunch according to coupons issued.

Canteen facilities to be run in the venue during the Tournament days so that Players and Guardians can avail the facilities on payment.

A.C. single room accommodation will be provided to Referee  
For TOs, good A.C. accommodation in twin sharing basis shall have to be provided.

A back-up Generator has to be kept for all the days of Tournament.

Ambulance and other medical support to be kept ready during all the days of Tournament.

**INAUGURATION** Inauguration ceremony to be kept up to half an hour duration.

**LINE JUDGES** :: It's mandatory to provide line judges from Main Draw onwards. For qualifying draws also, line judges are to be provided -two (2) minimum per court
