Double Entry	District forwarding names for Doubles partnering player from different District should have NOC or otherwise name of same pair should come from both the district failing which the entry will not be considered.
WITHDRAWALS	<p>Any player failing to participate in any UPBA approved tournaments after draw is made; he/she is liable to pay the entry fees as a fine to UPBA before participating in next tournament. District Association /Club shall ensure for the deposition of the withdrawal fee to UPBA.</p> <p>No exemption under any grounds (including medical) will be allowed in payment of fine. No player is permitted to participate in the next tournament without paying fine. Referee shall submit the withdrawal list to UPBA within 48 hours after completion of the tournament.</p>
Draw Date	12th June 2026
Mode of Completion	All matches shall be played on best of three games in rally point system. However, if needed the Referee in consultation with Organizing Secretary may take the decision as per need of the situation.
Clothing Regulations	Players must comply with General Competition Regulations.

Branding	<p>As "Yonex Sunrise" is the premier sponsor of Uttar Pradesh Badminton Association and the present tournament is a UPBA tournament the word "Yonex Sunrise" be prefixed before the name of the tournament.</p> <p>During the State Tournaments it is mandatory to use the following Yonex Sunrise particulars-</p> <ol style="list-style-type: none"> 1. Yonex Shuttles 2. Branding (Boards & Banners) 3. Yonex Sunrise Logo on all Banners & Back Drops 4. Organizing District Association/Club will provide the space for Yonex stall at venue if required. 5. Tournament Certificate & Banner must be approved by UPBA.
Referee	TBC Referee & Organizing Secretary shall ensure the fare and peaceful tournament. No parents/Coaches shall be allowed to argue with the Technical Official during the matches in the playing arena. If there is any doubt regarding the decision of the umpire, the concern person shall approach to the referee. The decision of the referee shall be final.

Protest	<ol style="list-style-type: none"> 1- Any protest during the tournament can be given prior to the match or within 30 Minutes of completion of the match. The protest along with the relevant documents and protest fee will be submitted to Referee. 2- The referee will check the documents of the said player, if satisfy, the player against whom the protest has been carried out, will be declared successful / unsuccessful by the referee in the following manner. <ol style="list-style-type: none"> a) If the protest is successful the entire protest fee will be refunded to the protestant and the guilty player may be debarred from the tournament.

	<p>b) In case of unsuccessful protest, disciplinary action may be initiated against the protestant player also.</p> <p>3- If referee will not be able to verify the documents than he will submit the protest case to Organizing Secretary, so that he can forward the case to age screening committee of UPBA.</p> <p>4- It is desired to all participants player to carry their birth certificate/age estimation certificate or any other relevant documents (original) for proof to verify his/her DOB to avoid the spot disqualification.</p> <p>5- The fees for lodging protest of any kind shall be Rs. 5000</p> <p>It is desired to all participants player to carry their birth certificate/age estimation certificate or any other relevant documents (original) for proof to verify his/her DOB to avoid the spot disqualification.</p>
<p>5Accommodation</p>	<p>Players have to make their own arrange for fooding and lodging. The organizer will provide the hotel details.</p> <ol style="list-style-type: none"> 1- TA/DA to all TO's Nominated by UPBA shall be provided by the organizer as per the UPBA rules. 2- The organizer will provide the hotel details soon. 3- Medical staff will be available for any emergency. 4- Logistics will be provided by the organizer such as drinking water, proper cleaning of the venue, changing room & Toilets. 5- AC accommodation will be provided to the TO's by the organiser. 6- The pickup & dropping facility for TO's will be provided from Venue to Hotel by the organiser. <p>For any clarification / assistance: please contact to- Mr. Dheeraj Sharma - 9696064280</p>

Note: If any players/participant found prima facie guilty for misconduct, misbehave and consume any prohibited thing like Alcohol, Cigarette etc. on court or off court the referee may take decision against the culprit by taking spot decision during the tournament and if referee feel, that further disciplinary action is required, may refer to the Secretary-UPBA for further disciplinary action against the such person.
